# PROMOTION OF ACCESS TO INFORMATION ACT SECTION 51 MANUAL

#### Introduction

This Manual is published in terms of Section 51 of the Promotion of Access to Information Act, 2000 (Act No. 2 of 2000) ("the Act"). The Act gives effect to the provisions of Section 32 of the Constitution, which provides for the right of access to information held by the State and to information held by another person that is required for the exercise and / or protection of any right.

The reference to any information in addition to that specifically required in terms of Section 51 of the Act does not create any right or entitlement (contractual or otherwise) to receive such information, other than in terms of the Act.

#### 1. V & S INNOVATIONS NAME OVERVIEW

**V and S Innovations** supports the constitutional right of access to information and we are committed to provide you access to our records in accordance with the provisions of the Act, the confidentiality we owe third parties and the principles of South African law.

#### 2. AVAILABILITY OF THIS MANUAL

#### 3. HOW TO REQUEST ACCESS TO RECORDS HELD BY V & S INNOVATION

Requests for access to records held by **V** and **S** Innovations must be made on the request forms that are available from our website and office, from the SAHRC website (<u>www.sahrc.org.za</u>) or the Department of Justice and Constitutional Development (<u>www.doj.gov.za</u>) (under "regulations").

A request fee may be payable. Annexure D can be accessed on the SAHRC website (<a href="www.sahrc.org.za">www.sahrc.org.za</a>) or the Department of Justice and Constitutional Development (<a href="www.doj.gov.za">www.doj.gov.za</a>, under "regulations"). You can submit a request without paying the request fee but please note that payment of the prescribed fees must be made before the request will be processed.

Requests for access to records must be made to our Information Officer at the address, fax number or electronic mail address provided for below.

The requester must provide sufficient detail on the request form to enable the Information Officer to identify the record and the requester. The requester should also indicate which form of access is required and indicate if he or she wishes to be informed in any other manner and state the necessary particulars to be so informed.

The requester must identify the right that he or she is seeking to exercise or protect and provide an explanation of why the requested record is required for the exercise or protection of that right.

If a request is made on behalf of a person, the requester must then submit proof of the capacity in which the requester is making the request to the satisfaction of the Information Officer of V and S Innovations.

The standard form, Annexure\_C\_Form\_C\_Request\_Form, that must be used for the making of requests can be accessed on the SAHRC website (www.sahrc.org.za) or the Department of Justice and Constitutional Development (www.doj.gov.za, under "regulations"). Not using this form could cause your request to be refused (if you do not provide sufficient information or otherwise) or delayed.

Kindly note that all requests to V and S Innovations will be evaluated and considered in accordance with the Act. Publication of this manual and describing the categories and subject matter of information held by V and S Innovations does not give rise to any rights (in contract or otherwise) to access such information or records except in terms of the Act.

- Internal correspondence;
- Product records;

#### 2. Personnel records

Personnel refers to any person who **V** and **S** Innovations and receives or is entitled to receive any remuneration and any other person who assists in carrying out or conducting the business of **V** and **S** Innovations. This includes, without limitation, directors, executive directors, non-executive directors, all permanent, temporary and part-time staff as well as contract workers. Personnel records include the following:

- Credit information and other research conducted in respect of customers;
- Any records a third party has provided to V and S Innovations about customers:
- Confidential, privileged, contractual and quasi-legal records of customers;
- Customer evaluation records:
- Customer profiling;
- Performance research conducted on behalf of customers or about customers;
- Any records a third party has provided to V and S Innovations either directly or indirectly; and
- Records generated by or within V and S Innovations pertaining to customers, including transactional records.

### 4. Technical records

Will be available, if applicable, on specified request.

#### 5. Other Parties

Records are kept in respect of other parties, including without limitation contractors, suppliers, joint ventures, service providers and general market conditions. In addition, such other parties may possess records, which can be said to belong to **V** and **S** Innovations. The following records fall under this category:

- Personnel, customer or V and S Innovations records which are held by another party as opposed to being held by V and S Innovations; and
- Records held by V and S Innovations pertaining to other parties, including financial records, correspondence, contractual records, electronic mail, logs, cached information, records provided by the other party, and records third parties have provided about the contractors/suppliers or customer.

## 6. Other Records
